1. **ALTERATION:** Unless otherwise stated in writing the price of the goods shall be the price ruling at the date of delivery.
2. **PRICES:** Prices are quoted 'exclusive of GST' unless stated.
3. **GST:** GST will be applied at the rate as deemed by the Australian Tax Office.
4. **FREIGHT:** Unless otherwise stated delivery to Metropolitan Sydney, Brisbane & Canberra is "Free into Store" – provided the order value is not less than \$600 (Inc GST). All other areas will be charged at cost. If the order value is less than \$600 (Inc GST) a delivery charge is applicable.
5. **TERMS:** Accounts are due and payable 30 days from date of invoice. Credit may be cancelled or suspended without notice if accounts are not paid by the due date. The purchaser acknowledges that Harcor Security Seals sets the payment terms. In the event where your overdue account is referred to a collection agency, you will be liable for all out-of-pocket expenses and all other reasonable expenses including debt collection commission (as if the account had been collected) and any other contingent expenses and legal costs on a solicitor/own basis incurred by us for enforcement of obligations and recovery of moneys due from you to Harcor Security Seals.
6. **TITLE:** Ownership and property shall pass from the Seller to the Buyer upon payment of goods in full. However if payment is not made within the agreed payment terms, the Seller shall without prejudice to any other remedies, be entitled to re-take possession of the goods.
7. **FORCE MAJEURE:** The Seller shall be entitled to delay or cancel delivery or to reduce the amount delivered if it is prevented from or hindered in or delayed in manufacturing, obtaining or delivering the goods by normal route or means of delivery through any circumstances beyond its control.
8. **CUSTOMISED GOODS:** Goods supplied to customised specifications, and without fault, will not be accepted for return or credit.
9. **RETURNS & CREDITS:** Unless approved otherwise, Goods ordered in error by the customer and returned for credit in saleable condition, are subject to a 10% restocking fee and must reference the original invoice number and return authority.
